



Totally Spies! Privacy Policy

This privacy policy is for the **Totally Spies!** Website, managed by Marathon Media.

This privacy policy describes what types of personal information we collect from children under age 13 and from other people on our website at www.totallyspies.com, what we use the information for, special conditions for registration of children under age 13, your rights concerning the personal information you or your child submits, and our disclosure policy.

Please note that this privacy policy applies to the English language website of www.totallyspies.com, intended for American visitors. Different policies may apply to totallyspies.com websites in other languages or intended for visitors from other countries.

CHILDREN'S ONLINE PRIVACY POLICY

Notice to parents / access and review of personal information

1. What we collect ?

When you register as a member of the T-Spies Club, we ask for the following personal information : your name and address, your email address, your birth date, a "code" name, and whether you are a boy or a girl. If you are under age 13, your registration is not complete until we have received your parent's consent. We may also collect personal information from parents in order to allow kids to participate.

2. Your parent's consent.

To register as a member of the T-Spies Club, you need your parent's or guardian's permission if you are under age 13. When you register, we inform you that we need your parents consent and ask for your parent's email and post address. We will send a letter to your address to inform your parent about your registration, and to ask them to give us their consent. If we do not receive their consent within 30 days, we will delete your registration information.

3. What we do with your information ?

We use your email address to send you emails. We review your information to see how you use our website, and to make improvements to our website. If you send us an email or artwork, we may post it on our website. We may send you emails from us about Totally Spies! At times, we may use your personal information to ask members of the T-Spies Club if they want to enter sweepstakes or contests, or send or receive e-cards, or review products or ideas, or engage in other similar/special activities. If we post the material you submit or send material to other people at your request, we may use your screen name or part of your email address, and your home town. We will not post or disclose your full name, your street address, or your full email address. We do not sell your personal information or disclose it to any other company for marketing or other purposes. Exceptions: We may disclose your personally identifiable information, as necessary, to the companies that help us with our business or fulfillment or if we are legally required to do so. We keep your personal information confidential and secure, and require our business affiliates to do the same.

4. NOTICE TO PARENTS / GUARDIAN :

When your child registers with the T-Spies Club, we collect the child's name, address, email address, age and gender. Our registration form reminds the child that a parent's or guardian's permission is needed to complete registration. If your child tries to register, we will send you by e-mail a permission form to print. The permission form asks you to print, sign and return the form to us to show your permission for your child to register with the T-Spies Club. If we do not receive the signed form from you within 30 days of such notice, we will delete your child's information and will not complete the registration. Registration is complete only after we have a parent's or guardian's permission for each child under 13 years. A complete registration is needed to access the T spies Club.

OTHER PRIVACY INFORMATION

5. Collection of Non-Personal Information – "Cookies" and other information.

We may collect some non-personal information from children under age 13, and from other visitors, by using small text files known as "cookies." We use Cookies for several purposes—for example, to recognize repeat visitors, to determine the number of unique visitors to our site and what pages they visit, and to improve our website. We may also allow unaffiliated third parties to place cookies on the hard drives of visitors to our websites. You may reject cookies, but then you will not be able to register with the T-Spies Club or to use other features on our website. The "help" button on the toolbar of most browsers will tell you how to configure your browser to reject new cookies, how to erase cookies from your hard drive, and will give other helpful information about cookies.

We may also collect other non-personal information – such as IP addresses, the type of operating system in use (e.g., Macintosh or Windows), the type of browser being used by the visitor (e.g., Netscape or Internet Explorer), and the number and frequency of visitors to our site. This data is routinely collected by the Internet servers on which our website is hosted. We may also use web beacons to count page visits by our users, to access our cookies, and otherwise to improve your experience on our website.

We may share aggregated demographic information about our visitors with our business affiliates and advertisers. This demographic information is not linked to any personal information that can identify any individual person.

SECURITY OF INFORMATION

We maintain physical, electronic and procedural safeguards to guard the personally identifiable information collected on our Website.

CORPORATE CHANGES

If Totally Spies!, Marathon Media, or any of its assets are acquired by another company, the T-Spies Club registrants and other personal information acquired by Totally Spies may be one of the assets transferred.

THIRD PARTY WEBSITES

We may provide links to other websites as a convenience. We are not responsible for the material on any website that is not owned by Marathon Media. Nor are we responsible for their privacy policies. We urge you to review the privacy policies of other websites you visit. Those privacy policies will govern the collection and use of information you provide when you visit those other sites.

CHANGES TO THIS PRIVACY POLICY

We reserve the right to change the terms of this Privacy Policy, including the Children's Online Privacy Policy. Any new terms will be posted on this website. We recommend that you check this site periodically, to review the current privacy policy.
